We ran 73 CodeDay events across 48 US cities from July 1, 2014 - June 30, 2015, serving over 7,000 student attendees. 75% of these students were new to programming, but over 80% reported they were still programming 3 months after attending CodeDay.

StudentRND is a fiscal sponsor for HACKER FUND, a program which shows teaches students about technology through programming events held in conjunction with schools, and matches students with mentors.
