CODEDAY is a 24-hour event to teach students about programming. We continued to CodeDay as our primary program, running 64 events in 38 cities across the US, with nearly 6,000 student attending in total. 75% of these students were new to programming, but over 70% of these beginner students reported that they were still coding two-and-a-half months after attending CodeDay.
